Project: 'Accelerating the Transition to a Net-Zero Nature-Positive Economy in Mauritius' (NZNPA)

Expression of Interest for shortlisting of suitable Consultants to act as Project Technical Coordinator (on Contract basis)

The Ministry invites interested national qualified consultants to submit their respective proposals, to act as **Project Technical Coordinator (PTC)**, on a full-time basis for a period of 4 years for the implementation of the above-mentioned project for which funding has been secured from the Global Environment Facility (GEF).

The NZNPA project aims to accelerate the decarbonisation of the manufacturing sector for higher productivity and enhanced competitiveness, as well as establish the enabling environment to support the integration of nature-based solutions at national level. The Ministry is the Executing Agency to lead the project implementation and the United Nations Environment Programme (UNEP) is the GEF Implementing Agency.

The Project Technical Coordinator shall be a Mauritian National who will be selected to head the Project Management Unit which will be responsible to manage the implementation and, monitoring and evaluation of the NZNPA Project. The requirements are as follows:

- at least a first degree in Engineering, Climate Change, Environmental Sciences, Sustainability, or any other related field of study;
- at least a Post Graduate qualification in Project Management, or any other related field of study;
- at least 5 years of work experience in managing similar projects;
- prior experience in managing at least one GEF-funded project;
- at least 2 years of experience working with ministries or other public institution(s);
- computer literate; and
- oral and written skills in English and French.

Interested candidates, who meet the above requirements and who wish to be considered for the above position, are required to send their proposals in sealed envelope clearly marked “**Expression of Interest -Consultancy Services for a Project Technical Coordinator under the NZNPA Project – Reference No: IND/EOI 01/2025 2026**”. The submission of proposals, including supporting documents (*e.g. signed Curriculum Vitae, documentary evidence of academic qualifications and work experience, amongst others*) should be addressed to the **Permanent Secretary, of the Ministry of Industry, SME and Cooperatives (Industry Division)**.

The Expression of Interest should be deposited in the **Quotation/Tender Box** located at 7th Floor, Air Mauritius Building, President John Kennedy Street, Port-Louis, **at latest, by 10.30 hours of Friday 15 August 2025.**
