

PERFORMANCE OF THE EXPORT-ORIENTED ENTERPRISES (EOEs)

The EOEs sector is an important pillar of the manufacturing industry, contributing significantly to economic growth, employment and foreign exchange earnings.

As at December 2023, the sector comprised 232 companies with a combined workforce of some 33,000 persons involved in production activities, such as Textile and Clothing, Fish Processing, Jewellery, Watches and Clocks and Medical Devices.

The EOEs sector continues to be vulnerable in the face of daunting challenges, both internally and externally. This state of affairs is further straining the existing difficult situation within which industry operators are evolving to maintain export market share.

As a consequence, the EOEs sector witnessed a setback in the year 2023 in terms of exports revenue. This is reflected in a drop of 5.1% in exports, from Rs 49.9 billion in the year 2022 compared to Rs 47.4 billion in the year 2023.

At sub-sectoral levels, export of Textile and Clothing declined by 16.6% in 2023 thus, representing a decrease from Rs 21.7 billion in year 2022 to Rs 18.1 billion in year 2023. Furthermore, exports of Jewellery/Pearls, Precious and Semi-Precious Stones also registered a negative growth of 15%, with export declining from Rs 5.5 billion in year 2022 to Rs 4.6 billion in year 2023.

This negative export growth has been mitigated by the favourable performance demonstrated by the Fish and Fish Preparations and Medical Devices sectors, which registered a growth of 3.1% and 12.6%, respectively in year 2023.




Figure 1: Sub-Sectoral Export Performance for the years 2022 and 2023

This sub-sectoral performance is depicted in Figure 1.




Figure 2: EOEs Exports to Market Destinations

South Africa remains the leading market destination, followed by United Kingdom, USA and France, as illustrated in Figure 2.

In this period of uncertainty and fierce global competition, the unflinching support of Government has proved to be crucial for the EOEs sector to retain market shares and explore new business horizons. Efforts are also being pursued to refine the supply-side capabilities of EOEs to improve their competitive edge through digitalization of production processes, adoption of sustainable practices as well as productivity and quality enhancement programmes. Above all, the export promotion strategy is being revisited to unlock market opportunities arising from new Trade Agreements.

ACTIVITY

"RENEWAL OF REGISTRATION OF DEALERS IN JEWELLERY AT THE ASSAY OFFICE"

01 December 2023 - 29 February 2024

According to the Jewellery Act 2007, any person dealing in jewellery or precious and semi-precious stones business has to be registered with the Assay Office.

Once registered, a Certificate of Registration as 'Dealer in Jewellery' is issued to the dealer which is valid for a period not exceeding three years. Upon expiry of the Certificate of Registration, the 'dealers in jewellery' may renew their registration and pay the prescribed fees depending on the nature of activity as mentioned below.

564 jewellers were supposed to renew their Certificate of Registration from December 2023 to February 2024. In line with the Jewellery (Dealer's Registration and Transactions) Regulations 2012, individual dealers, directors, shareholders, and beneficial owners of registered companies were required to produce a Certificate of Character issued by the Office of the Director of Public Prosecutions (DPP). The aim was to ensure that 'dealers in jewellery' were still 'fit and proper' to deal in jewellery, precious metals and precious stones.

Whilst, the responsibility to renew registration primarily rests with the jewellers, the Assay Office initiated meetings with the Federation of Jewellers and different Associations of Jewellers to disseminate information on the procedures for the renewal of registration of dealers in jewellery. Besides, letters, SMS, WhatsApp messages were sent and notices were displayed on the website of the Assay Office to share information on the renewal process.

The Certificates of Registration of 518 jewellers were successfully renewed during the renewal exercise as shown in the table below:

Out of 564 registered jewellers, 46 did not renew their registration as they have ceased business as 'dealer in jewellery'. In order to ensure that no person deals in jewellery without being registered with the Assay Office, inspection visits are being carried out. The bulk renewal exercise was completed with the fruitful collaboration of the Commissioner of Police and the Office of the Director of Public Prosecutions. The next bulk renewal exercise will be carried out in February 2027.

MAURITIUS ACCREDITATION SERVICE (MAURITAS)

TRAINING COURSE ON ISO 15189:2022

05 - 08 February 2024

In a modern dynamic healthcare landscape, quality is of paramount importance and there is a growing need to adhere to internationally recognised standards to ensure accuracy and reliability in medical testing processes.

In this perspective, the Mauritius Accreditation Service (MAURITAS) accredits medical laboratories which are developing their quality and management systems as well as assessing their own competence, through the adoption of ISO 15189:2012, the international standard which specifies requirements for quality and competence in medical laboratories.

As at date, the MAURITAS has accredited 7 medical laboratories against the requirements of ISO 15189:2012 'Medical Laboratories – Requirements for quality and competence' in Mauritius. The 7 medical laboratories are accredited for a total of 148 parameters in the biochemistry, immunology, haematology and microbiology medical sub-fields. Following the publication of the latest version of the ISO 15189 in December 2022, MAURITAS organised a training course from 05 to 08 February 2024, for its staff, assessors and other stakeholders on the requirements of the updated standard, to ensure the integrity of its accreditation process for medical laboratories.

A total of 21 participants attended the training course which was conducted by Dr. S. Chakraborty, Director-Institute of Applied Quality Management Consultants Pvt Ltd, India. The four-day training course encompassed a multifaceted approach of acquiring technical knowledge and skills upgrading. Through interactive sessions, engaging discussions and analysis of case studies, participants gained a comprehensive understanding of the key principles of the updated standard and its practical implications.

The training course has equipped the professionals with latest techniques to navigate the revised standard and ensure accreditation of medical laboratories to the updated standard, thereby, paving the way for enhanced quality and excellence in the health sector.



VISIT OF QUALITY INFRASTRUCTURE EXPERT AT MAURITIUS STANDARDS BUREAU (MSB)

20 February 2024

The Quality Infrastructure of a country plays an important role in supporting the economic development, promoting public welfare and ensuring sustainable growth. It forms the backbone of a strong society, provides the necessary framework for various activities and improves the overall quality of life for citizens. The Mauritius Standards Bureau plays an important role in the National Quality Infrastructure to ensure quality and safety of products and services in the country.

In February 2024, the Bureau welcomed Mr. C. Kudahl, a Quality Expert in Standardisation who had a mission to formulate a National Standardisation Strategy (NSS) for MSB under the Regulatory Review Project (RRP). The RRP is funded by the European Union and aims to implement major regulatory reforms in Mauritius for business facilitation.

Mr. C. Kudahl is a Danish National with more than 25 years of professional experience in the field of Quality Infrastructure and Standardisation. He has worked in numerous developing countries and has supported the development of National Quality Infrastructure systems and legislative frameworks of consumer safety as well as strengthened National Standardisation Bodies.

Mr. C. Kudahl's current assignment entails working in tandem with the MSB and its partners to develop a Strategic Roadmap and formulate critical focus areas that will underpin and drive sustainable development initiatives in the field of Standardisation.

The importance of the National Standardisation Strategy (NSS) for MSB is multifaceted and encompasses various aspects which are crucial for the growth and competitiveness of our industries.

The NSS will consider the Government's roadmap in terms of the development of the specific economic sectors, and will identify priority areas which should be supported by the National and International Standards. It will also specify the means to achieve the set objectives.

At the individual online training level, participants were engaged in a comprehensive curriculum covering essential leadership competencies based on the Mauritius Leadership Brand, productivity concepts, personal competence, social competence, critical thinking, creativity and project management. The Honourable (Ms.) Naveena Ramyad, Minister of Industrial Development, SMEs and Cooperatives officially launched the opening ceremony of the validation workshop in the presence of Her Excellency (Ms.) Lisa Simrique Singh, the United Nations Resident Coordinator for Mauritius and Seychelles.

Some 70 participants, including representatives of institutions, academia, business associations and manufacturing enterprises, attended the workshop. The aim of the workshop was to validate inputs gathered to draft the NZNPA Project Document which would elaborate the modalities, institutional arrangements and activities over the next four years of implementation.

During her keynote address, the Honourable (Ms.) Naveena Ramyad, Minister of Industrial Development, SMEs and Cooperatives expressed her gratitude to the Global Environment Facility (GEF) and the United Nations Environment Programme for their support in the implementation of the first phase of the project, namely, the preparation of the NZNPA Project Document which has been submitted to the GEF Council for approval in June 2024.

She seized the opportunity to highlight that the manufacturing sector, a major pillar of the Mauritian economy, has been instrumental in shaping the socioeconomic landscape of the country and contributes significantly to foreign exchange employment creation and improvement of living standards. She added that although the sector has been able to build back its resilience from Covid-19 pandemic, it is confronting other challenges from both internal and external fronts. Nevertheless, she commended the efforts of the industry captains for their perseverance and commitments in shaping a sustainable and prosperous future for the country. She concluded by pointing out the multiple benefits of the NZNPA project such as enhanced productivity and competitiveness of the manufacturing sector, mitigation of greenhouse gas emissions, increased adoption of sustainable practices, reduction of dependency on imported materials and fossil fuels while ensuring sustainable management of our natural resources and protection of our ecosystems and biodiversity.

INTERVIEW

MAURITIUS STANDARDS BUREAU: UNDERSTANDING CONCRETE GRADE

28 February 2024

With climatic change and extreme weather conditions, we are observing a pattern of roofs cracking and leaking in houses. Mr. K Pareemamun, Manager of the Civil Engineering Laboratory of Mauritius Standards Bureau (MSB) was interviewed to understand the issues related to concrete roofs, cracks, and leaks. His responses to a few key queries are as follows:

i) Houses are being built every day and people would like to know more about the quality of cement used in construction, especially when cracks in roofs are a common problem.

Mr. K. Pareemamun stated that there are several factors which can cause cracks and leaks such as poor workmanship, low-grade materials and the drying process of concrete roofs. He laid emphasis on one aspect which is related to the quality of concrete (mixture of aggregates, water, and cement) being used and how this can directly impact the durability of concrete roofs.

The compressive strength of concrete used in a roof is influenced by factors which include the water-cement ratio, cement strength and the quality of concrete (ingredient ratio) materials used. When one purchases concrete, it is important to choose a supplier who adheres to strict quality standards and uses high-grade materials, as this will directly impact the final strength of concrete.

Fortunately, in Mauritius, the cement being imported is controlled by the Third Schedule of Consumer Protection Safety Requirements Regulations 2019, which ensures that imported cement complies with the standard MS EN 197 part 1 or equivalent ones.

ii) Grade 25 is often used as a jargon in the construction of domestic houses. Can you please provide more details?

As a rule of thumb, people in Mauritius usually use Grade 25 concrete when building a house. The term "grade 25 concrete" typically refers to a specific strength of concrete, which is determined by its compressive strength measured in megapascals (MPa). In this context, grade 25 concrete has a compressive strength of 25 megapascals.

Concrete grades are classified based on their compressive strength and they are denoted by a number such as 20, 25, 30, 35, etc. The higher the number, the greater the compressive strength of the concrete.

It is important to note that the mix design, curing conditions and other factors, also play a role in determining the overall performance and characteristics of concrete in addition to its grade.

iii) How can we know the grade of concrete used in a construction?

Concrete cube - cylinder testing is a way to accurately assess the true strength of the concrete. The process includes pouring fresh concrete into moulds to form cubes, which are then cured and tested typically after 7 and 28 days. The test can tell you the grade of the concrete mix. The cubes are normally tested at two key ages: 7 days and 28 days after casting. The 7-day test helps in quickly identifying any potential problems with the concrete mix, while the 28-day test is generally considered the standard time for assessing the cured strength of the concrete.

Anyone who purchases concrete from a local supplier is invited to test his/her samples at the Civil Engineering Laboratory of the MSB.

iv) What happens if the compressive strength of a sample is lower than the expected grade?

The result provided for testing of concrete cubes at MSB, is accredited by the Mauritius Accreditation Service (MAURITAS). This means that the Bureau has the technical competence to produce accurate and reliable tests. Clients can use the test reports issued by MSB to claim their suppliers in case the latter deliver lower grade of concrete which do not match with the grade of concrete at the time of purchase.

ITEC INTERNATIONAL TRAINING

EMERGING AREAS IN TECHNICAL TEXTILES

13 February to 23 March 2024

Two staff of the Academy of Design and Innovation (ADI), namely, Ms. D. Ramrecha from the Arts and Design department and Mr. L.K. Ruttun from the Fashion and Textile department attended a training programme on technical textiles at the South Indian Textile Research Association (SITRA), in Coimbatore, India from 13 February to 23 March 2024.

IMPROVING HEALTHCARE QUALITY: INITIAL ASSESSMENT OF MEDICAL LABORATORIES

23 - 26 April 2024

Quality in a laboratory is a broad concept which extends beyond producing results that are reliable and accurate. It encompasses a comprehensive approach that includes adherence to set norms and standards. In an ongoing effort to maintain standards of excellence, MAURITAS performed the Initial Assessments of two medical laboratories—one in accordance with ISO 15189:2012, and the other as per the 2022 version of the standard. These assessments, which were conducted from 23 to 26 April 2024, served as a critical step in the accreditation process, allowing MAURITAS to evaluate the laboratories and their respective collection points for compliance with internationally recognised standards.

Following the Initial Assessments, the laboratories were required to address identified nonconformities by implementing corrective actions to demonstrate an improved performance of their quality management systems. Once the necessary corrective actions have been undertaken and evidence thereof submitted to MAURITAS, the Accreditation Committee will decide upon the grant of accreditation to the laboratories.

Accreditation positions medical laboratories as trusted entities, upholds their credibility, fosters international recognition and serves as a hallmark of quality and competence.

Accredited medical laboratories thus demonstrate dedication to deliver high-quality healthcare services and contribute to enhancing patient safety and satisfaction.

13 May 2024

On 13 May 2024, two consultants from the United Nations Economic Commission for Africa (UNECA), Mr. S. Abdallah, Economic Affairs Officer from the African Trade Policy Centre and Mr. W. Gameledin, the Lead Consultant, paid a courtesy call on the Honourable (Ms.) Naveena Ramyad, Minister of Industrial Development, SMEs and Cooperatives.

The consultants apprised the Honourable Minister about the preparation of a project report on the establishment of a database of raw materials available in Africa for the Textile and Cotton Industry to facilitate trade under the African Continental Free Trade Area (AfCFTA). African countries, namely, Mauritius, Lesotho, Kenya, South Africa, Ivory Coast, Cameroon, Mali, Morocco and Egypt have been selected to form part of the project.

The UNECA consultants informed that their visit to Mauritius was held in the context of a field mission to collect data on the local textile and clothing sector. In this perspective, they met several public and private sector stakeholders such as Statistics Mauritius, Economic Development Board, Mauritius Export Association and Mauritius Chamber of Commerce and Industry. They also conducted site visits to manufacturing enterprises such as RT Knits Ltd, Firemount Textiles Ltd and Tianli Spinning (Mauritius) Mills Company Ltd in an endeavour to have insights on their needs for material inputs (e.g., cotton, cotton yarns and fabrics).

The report of the consultants would be ready by July 2024 and would serve as a guide for Member States to source cotton-based raw materials from the African region for sustainable production. It would also be useful to Member States to formulate their respective value propositions during negotiations on Rules of Origin under the AfCFTA regime.

SEMINAR ON THE WORLD METROLOGY DAY 2024 AT THE MAURITIUS STANDARDS BUREAU



20 May 2024

The World Metrology Day is celebrated on May 20th each year. It commemorates the anniversary of the signing of the Metre Convention in year 1875, which established the International System of Units (SI) and laid the groundwork for global cooperation in metrology, the science of measurement.

On this occasion, the Mauritius Standards Bureau (MSB) organised a seminar on Monday, 20 May 2024 to celebrate the World Metrology Day, under the theme: "We measure today for a sustainable tomorrow". The aim of the seminar was to raise awareness about the importance of measurement in all aspects of human endeavor and highlight the critical role that accurate and reliable measurements play in trade, innovation, consumer protection, environmental sustainability and international cooperation.

The Honourable (Ms.) Naveena Ramyad, Minister of Industrial Development, SMEs and Cooperatives graced the event with her presence and in her keynote address, she highlighted the importance of accurate measurements in policy-making and the role of MSB in maintaining standards for critical parameters through calibration services.

She stressed on the significance of National Metrology Institutes in fostering innovation and their impacts on sectors like healthcare.

She also emphasised on the role of metrology to address sustainability challenges, supporting governments in monitoring progress towards the UN Sustainable Development Goals and implementing resilience-promoting policies.

Mr. S. Mulloo, the Chairperson of the Standards Council of MSB, in his speech, laid emphasis on the way the science of measurement avers to be a universal phenomenon, essential for maintaining quality across diverse manufacturing technologies. Mrs. L. Chummun-Bhujohory, the Director of MSB, on her part, indicated that measurement was the foundation of science and technology, crucial for supporting modern civilisation. She emphasised the importance of precision in an era of artificial intelligence and automation, cautioning that without accurate measurements the integrity of systems, product safety, and fundamental trust necessary for progress, could be compromised.

The seminar was further enriched by contributions from three key resource persons namely: Mr. R. Ramlugon, Group Chief Sustainability Officer of Omnicane Management and Consultancy Ltd, Mr. V. Gowd, Manager of the Economic Development Board, and Mr. C. Ng Ha Kwong, Head of the Metrology Unit at MSB.

Individuals from the scientific and educational fields and stakeholders of MSB, who were present in the audience, acknowledged that the event was a rewarding experience for them, as they gained valuable insights in the field of measurements and its application in daily life.
