Launching of the Industrial Policy and Strategic Plan 2020-2025

On 04 December 2020, the Ministry of Industrial Development, SMEs and Cooperatives (Industrial Development Division) launched its Industrial Policy and Strategy Plan (IPSP) (2020-2025) as a roadmap to shape the future contours of industrial development. This was made possible with the technical and financial assistance of the United Nations Conference on Trade and Development (UNCTAD), with Professor Justin Barnes as Consultant for the project.



The IPSP is the outcome of extensive consultations with all stakeholders of the manufacturing sector. It aims at uplifting the manufacturing sector to a more competitive, innovative, technology-driven and resource-efficiency pedestal to withstand the global emerging challenges. The IPSP revolves around five Focus Areas, namely industry foundations, upgrading of value chains, increased

domestic market supply, regional and global export growth and advanced technology absorption. It incorporates also sectoral recommendations for four key sectors, namely textile & clothing, food processing and fish preparations, medical devices and pharmaceuticals, and jewellery.

Key stakeholders, including MEXA, Business Mauritius, AMM and EDB Mauritius as well as Captains of Industry were present during the launching ceremony. UNCTAD was virtually represented by Mr. Richard Kozul-Wright, Director of the Globalisation and Development Strategy Division, Mr. Pierguiseppe Fortunato, Project Leader, including Professor Justin Barnes.

FACTORY VISIT

Visit to a Garment Factory - Wensum Ltd



The Minister of Industrial Development, SMEs and Cooperatives, Honourable S. Bholah, effected a visit at Wensum Ltd. situated at La Brasserie Forest Side, on 02 March 2021. The enterprise started operation as Corona Clothing Ltd in 1971 with an Export Processing Zone (EPZ) certificate. It has since undergone several takeovers and is now owned locally.

Wensum Ltd manufactures tailor-made suits and formal wear for exports to UK, EU, USA, Asia and Africa. Wensum Ltd has exported suits to renowned international entities such as Bespoken, Carini, Serge Blanco, Harrods and Christian Dior.

resilience and The company has shown safeguarded the jobs of some 330 employees despite the daunting challenges brought about by the outbreak of Covid-19 pandemic.

During the visit, the Minister emphasized that Government has put in place a host of support measures such as the Freight Rebate Scheme and the Trade Promotion Marketing Scheme to assist enterprises in their efforts to enhance competitiveness.

The Assay Office

The Assay Office, set up under the Jewellery Act 2007, ensures that the Jewellery Industry operates within the existing legal framework to safeguard the interest of consumers when buying and selling jewellery as well as to foster greater confidence among consumers.



It operates two laboratories:

- Assay Laboratory for testing of Jewellery or alloys made of Gold, Silver and Platinum. It is the first Public laboratory accredited to ISO/ IEC 17025 by MAURITAS.
- Gemmology Laboratory for verification of Gemstones and Grading of Diamond. It is certified to MS ISO 9001: 2015 by the MSB.



The Assay Office, through regular in spections, ensures that jewellery offered for sale in jewellery shops conform to national norms. On average, 550 visits are carried out annually for consumer protection.

Any person willing to sell his jewellery has to fill in an Ownership Declaration Form (ODF) at the jeweller's business premises and produce it to the Assay Office or to the nearest Police Station in his locality whereby his name and address are certified against his NIC and utility bill for proof of address.



The person should pay a prescribed fee based on the mass of the jewellery:

- For jewellery of mass less or equal to 5g, a payment of Rs 100 is required.
- For jewellery of mass greater than 5g, a payment of Rs 300 is required. The person is guaranteed of obtaining 70% of the price of gold based on the gold content in his jewellery.

Background


The Mauritius Accreditation Service (MAURITAS) is a Department under the Ministry responsible for the subject of Industrial Development, following the adoption of the MAURITIUS ACCREDITATION **SERVICE ACT 1998.**


Main Functions

The main functions of MAURITAS are to:

- provide a national, unified service for the accreditation of conformity assessment bodies (CABs) i.e laboratories, certification and inspection bodies.
- To establish agreements on mutual recognition with other national, regional and international accreditation bodies and to obtain and maintain international acceptance of the competence of organisations accredited by MAURITAS.

Difference between accreditation and certification.

- Accreditation is a formal recognition of the competence of an organization.
- Certification confirms compliance of an organization to standards.

- Laboratories (testing and calibration) as per MS ISO/IEC 17025 and
- Laboratories (medical) as per MS ISO 15189
- Certification bodies as per MS ISO/IEC 17021-1

Sustainable Gift Boxes



Award of the National Leadership Engine (NLE) 2020

The National Productivity and Competitiveness Council (NPCC) organised its second edition of the National Leadership Engine (NLE) Convention on Saturday 23 January 2021 at the Octave Wiéhé Auditorium, Réduit where the Prime Minister, Honourable Pravind Kumar Jugnauth, was the Chief Guest of the function.

The NLE project aims at building leadership capabilities among youth in Mauritius. The NLE is based on the "Leadership Brand", developed by the NPCC with various stakeholders in 2015. Award of the National Leadership Engine (NLE) 2020 projects



First Runner Up: Donn li so coco (Mahébourg Youth Centre) - The project was about producing pots based on coconut shells as a substitute for normal plastic pots for plant potting purposes.

Some 40 projects were successfully implemented in NLE 2020 and involved more than 300 youths. Former team leaders of NLE 2019 were roped in NLE 2020 as co-trainers. The projects covered issues in the participants' respective communities. They had to come up with sustainable solutions to these issues and through the whole project demonstrate their abilities and leadership skills.

At the event, Honourable S. Bholah, highlighted the importance to rethink the post-Covid economic and social architecture. The country more than ever needs the youth of Mauritius to face the challenges imposed by Covid-19. Young people will have a major role to play in restarting economic activities to boost up the economy.
